

## 2023 Superhero Secret Mission Trail | Terms and Conditions

### Details:

- a. Promotion: Superhero Secret Mission Trail
- b. Promoter: City of Fremantle (Visit Fremantle), Walyalup Civic Centre, 151 High Street, Fremantle WA 6160
- c. Promotional period: 11:30 am – 4:00 pm daily from Monday 2 – Friday 6 October 2023.

### Conditions of entry:

1. To enter the competition, entrants must unscramble the word found at each of the three locations to crack the codeword and complete entry form by way of scanning the QR code found on the trail map. Completed entry forms must be submitted prior to 5 pm on Friday 6 October 2023.
2. One entry per child (aged 12 and under).
3. The prizes will only be presented to the parent or legal guardian of the children who win.
4. The activation commences at 11:30 am (AWST) on Monday 2 October 2023 and closes at 4 pm (AWST) on Friday 6 October 2023.
5. Entries will be accepted from 11:30 am (AWST) on Monday 2 October 2023 and close at 5 pm (AWST) on Friday 6 October 2023.
6. Entrants must provide an email address and telephone number so that the winner can be contacted to redeem their prize.
7. The winners will be manually selected at random on Wednesday 11 October 2023 and the draw will be conducted and witnessed by City of Fremantle staff.
8. There will be two (2) winning entries selected. Prizes as below:
  - 1<sup>st</sup> prize – Clancy's Fremantle voucher valued at \$100.
  - 2<sup>nd</sup> prize – Twin Fin voucher valued at \$100.
9. Prizes must be redeemed within 6 months.

11. In order to arrange for the prizes to be redeemed, contact details of winners may be provided to the businesses sponsoring the prizes.
12. Valid and eligible entries will be accepted during the Promotional Period. A valid entry has unscrambled the codewords from each of the three locations – Fremantle Fishing Boat Harbour, Walyalup Koort / Old Courthouse and Clancy's Fish Pub Fremantle (Princess May Park).

### General conditions of entry:

1. Employees of the City of Fremantle, participating businesses (attractions, sponsors and influencers) and their immediate families are not eligible to enter the competition.

2. Eligible entrants: Entry is open to entrants who are aged 2-12. All entrants must have parent or legal guardian approval to enter.

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize.
4. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win.
