Terms & Conditions of Hire

The Term ‘Hirer’ – Whenever used herein, the term “hirer” refers to the person listed under the Hirer Details section on the Fremantle Visitor Centre Bike Hire Contract hirer. The Hirer is the person responsible for all equipment issued by the City of Fremantle/Fremantle Visitor Centre.

The Term ‘Equipment’ – Whenever used herein, the term “equipment” shall include any equipment hired from the City of Fremantle, including helmets and locks. As the hirer, I understand and agrees that the equipment described in this contract remains the property of the City of Fremantle and that the failure by the hirer to return said equipment to Fremantle Visitor Centre within the time provided in this contract may constitute a crime and subject the hirer to criminal prosecution.

Hirer liability – the hirer understands and agrees to assume liability for all damage or loss to personal property, accident/injury to other persons related to the hirers use or possession of the said equipment.

Hire Period – As the hirer, I understand that all equipment must be returned directly to the Fremantle Visitor Centre before 4:30pm from Monday to Friday and before 3:30pm on Saturdays, Sundays and Public Holidays, on the same day as the Hire Date (no overnight hires available). I also understand that I must contact the Fremantle Visitor Centre on +618 9432 9988 should I estimate, I will arrive later than the return time.

Late return fee – As the hirer, I understand and agree that the bond provided will be retained by the Fremantle Visitor Centre should the equipment not be returned to the Fremantle Visitor Centre on the Hire Date specified on this contract.

Local Laws – I as the hirer and all additional riders, agree to obey the local laws found in the Road Traffic Act 1974, Road Traffic Code 2000 and Road Traffic (Bicycles) Regulations 2002.

Bond Payment – I as the hirer understand that although there is no cost to hire the bikes, there is a Bond Payable for the hire which will be either paid for in cash (AU\$) or deducted from your debit/ credit card at the commencement of your hire.

The City of Fremantle/Fremantle Visitor Centre is not liable or responsible for any delays, fees, or charges that your financial institution may charge you.

Please ensure that the card in which you pay your deposit, also accepts refunds for the reimbursement of your bond.

The cost of the bond is \$50 per bike or \$100 family bond (2x standard bike plus 2x child bikes, or any combination of standard and child bikes, 2+2, 2+1, 1+2) applies.

Bond Refund – I as the hirer understand that the refund of the Bond will be processed in the same method of payment (cash or card) at the conclusion of your hire less any applicable fees or charges caused by damages or losses to the equipment should there be any. The City of Fremantle/Fremantle Visitor Centre is not liable or responsible for any delays, fees, or charges that your financial institution may charge you.

Responsibility for damage or loss – I as the hirer, understand and agree that upon return of the equipment, it is to be in the same condition as when it was received, ordinary wear and tear is expected and excepted. I as the hirer also understand and agree that I am responsible for all equipment issued to myself and my additional riders and should any part of the equipment be lost, stolen, damaged or broken, I agree to fully reimburse the City of Fremantle for the repair or replacement regardless of the party at fault and to the extent permitted by the law. Where possible the cost/s will be withheld from the bond. However, should the costs exceed the bond total, I as the hirer understands and agree that I will pay for the remaining expenses costs.

Subleasing – I as the hirer, understand and agree that any subleasing or reletting of the hire equipment is prohibited and that any such sublease or reletting shall immediately cause termination and cancellation of this contract.

Proximity of hire area – I as the hirer, understand and agree that the equipment is:

- Only to be used within the Fremantle area or within a 10km radius of Walyalup Koort, Fremantle
- Not to be ridden or taken onto any beach or sandy areas including during locked up periods
- Bikes are not permitted to be taken to Rottnest Island
