

FUNMANTLE Adventure Trail | Terms and Conditions | 2025

Details:

- a. Promotion: FUNMANTLE
- b. Promoter: City of Fremantle, PO Box 807 Fremantle WA 6959 in partnership with:
 - a. Fremantle Fishing Boat Harbour Traders
 - b. Fremantle Ports
- c. Promotional period: Monday 13 January Sunday 19 January 2025

General conditions of entry:

- 1. Employees of the City of Fremantle and their immediate families are not eligible to enter the competition.
- 2. Participating partner business owners and their staff are not eligible to enter the competition.
- 3. Entrants under the age of 12 must have parent or legal guardian approval to enter.
- 4. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize.
- 5. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. Should they subscribe, the email address will be manually subscribed to the list before the physical form is securely stored.

- 13. The parent or legal guardian of the entrant(s) agrees and acknowledges that they have read these Conditions of Entry and that entry into the Promotion is deemed to be acceptance of these Conditions of Entry.

Conditions of entry:

- To enter the competition, entrants must obtain trail maps by purchasing a ticket to FUNMANTLE. Entrants must then find and record two of three codewords located at key locations (Victoria Quay, Walyalup Koort and Fremantle Fishing Boat Harbour). To submit entry, participants scan the QR code found on the trail map, enter required details and submit the linked form.
- 2. One entry per person.
- 3. The vouchers/prizes will only be presented to the parent or legal guardian of the children (under 12) who win.
- 4. The trail commences at 01.00 pm (AWST) on Monday 19 January 2025 and closes at 7.00 pm (AWST) on Sunday 19 January 2025.
- 5. Entries will be accepted from 01.00 pm (AWST) on Monday 19 January 2025 and close at 8.00 pm (AWST) on Wednesday 22 January 2025
- 6. Entrants must provide an email address and telephone number so that the winner can be contacted to redeem their prize.
- 7. The winners will be manually selected at random by a City of Fremantle staff member and the draw will be witnessed.
- 8. There will be ten (3) winning entries selected.
